#### **January is Cervical Cancer Awareness Month**

Cervical cancer is a disease in which cancer cells arise in the cervix. Screening and prevention have significantly reduced the impact of cervical cancer. Today, nearly 14,500 women in the United States received a cervical cancer diagnosis and more than 4,200 have died from the disease in the last year.

#### Did you know?...

- Cervical cancer can be caused by infections with pathogens bacteria, viruses, and parasites
- Cervical cancer develops slowly over time
- A Pap test screening can:
  - o Detect cancer at an early stage, when treatment outcomes tend to be better
  - Detect precancerous abnormalities, which can be treated to prevent development of cancer
  - If detected early, cervical cancer is one of the most successfully treatable cancers
- The leading cause of cervical cancer is the Human Papilloma Virus (HPV)
  - The U.S. FDA has approved three vaccines that prevent infections with certain subtypes of HPV Gardasil, Gardasil
    9, and Cervarix.
